Rules (subject to be modified or changed)

- The Deadwood Chamber of Commerce reserves the right to refuse any booth that does not comply with the standards set by the City of Deadwood.
- Food and drink vendors with items available for immediate consumption (food trucks ect.) will not be allowed. Packaged food items will be considered.
- Payment must be made upon selection by the cutoff date of June 9th, 2025. Payments will be made to The Deadwood Chamber of Commerce by cash, check, or CC. All booths must be paid in full before set up can begin.
- All exhibitors are responsible for collecting and reporting their own sales tax.
- Vendors must provide a copy of their SD Sales Tax License. Please send a copy with the return of this application.
- All exhibitors are responsible for furnishing and setting up their own booth/tent.
- Tents will not be provided. All tables, signage, canopies, ect must be furnished by the vendor
- Vendors may not park vehicles or trailers on Main St next to or behind their booths.
- Vendors are required to be present for the whole duration of the event.
- Vendors must comply with related federal and state laws, South Dakota codified laws, and the SD Department of Health and regulations.
- Set up will begin at 8am on Friday June 13th. Vendors must follow set up procedures set by the event: Unload everything before setting up your booth then move and park vehicles off Main St before beginning booth set up.
- Tear down will begin at 6pm Saturday June 14th.
- Hours of the event will be 10am – 6pm each day on Friday June 13th and 14th.
- Overnight security will be provided so vendor spaces may remain set up.
